By visiting the Website https://dexnet.one as a Visitor, you Consent to the practices described below. Please refrain from visiting the Website as a Visitor if you do not accept this Cookies Policy, the Privacy Policy and/or the User Agreement. Definitions:

«Consent» shall mean any freely given, specific, informed and unambiguous indication of which the Data subject, by a statement or by a clear affirmative action, signifies agreement to the processing of Personal data relating to him or her.

«Cookie(s)» means a piece of information that is placed automatically on your computer's hard drive when you access the Dexnet Information Technology CO Website. The Cookies uniquely identifies your browser to the server. Cookies allow the Dexnet Information Technology CO to store information on the server and the User's preferences (for example language preferences, technical information, click or path information, etc.) to help make the dexnet.one Website experience better for you and to conduct Dexnet Information Technology CO Website analysis and performance review. The types of Cookies are further explained in Section 2 of this Cookies Policy.

«Data subject» shall mean the natural or legal persons whose data is processed, in the context of this Cookies Policy, the Visitor.

«Personal data» shall mean any information relating to an identified or identifiable natural person; an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

1. Introduction

At Dexnet Information Technology CO we believe in being transparent and open about the way we collect and use data related to you. The Website uses Cookies to distinguish you from other users of the Website. This helps us to provide you with the best experience when you browse the Website and also allows us to improve the Website. By continuing to browse on the Website, you are agreeing to the use of cookies.

2. Type of Cookies

- **Persistent cookies** remain on a user's device for a set period of time specified in the cookie. They are activated each time that the user visits the website that created that particular cookie.
- Session cookies are temporary. They allow website operators to link the actions of a user during a browser session. A browser session starts when a user opens the browser window and finishes when they close the browser window. Once you close the browser, all session cookies are deleted.
- Cookies also have, broadly speaking, four different functions and can be categorized as follows:

Strictly necessary cookies

These are Cookies that are required for the operation of the Website. They include, for example, Cookies that enable you to log into secure areas of the Website and enter into transactions. Without them, you wouldn't be able to use basic services like registration or viewing posted offers. These cookies do not gather information about you that could be used for marketing or remembering where you've been on the internet.

Analytical/performance cookies

They allow us to recognize and count the number of Visitors and to see how Visitors move around the Website when they are using it. This helps us to improve the way the Website works, for example, by ensuring that users are finding what they are looking for easily. We use Google Analytics Cookies which collects information anonymously. It reports Website trends without identifying individual visitors. You can opt out of Google Analytics without affecting how you visit the Website. Advertising and Targeting cookies

These Cookies record your visit to the Website, the pages you have visited and the links you have followed. We will use this information to make the Website and the advertising displayed on it more relevant to your interests. We may also share this information with Third parties for this purpose.

They cannot determine who you are though, as the data collected is never linked to your profile. The two main ways we use advertising and targeting cookies are set out below:

- Interest-based advertising (or online behavioral advertising) is where cookies are placed on your device by our third-party service providers which remember your web browsing activity and group together your interests in order to provide you with targeted advertisements which are more relevant to you when you visit Dexnet Information Technology CO Website. This information may also be used to make the advertising on Dexnet Information Technology CO Website more relevant to you.

- Retargeting is a form of interest-based advertising that enables our advertising partners to show you advertisements selected based on your online browsing activity away from the Website. Functionality cookies

1. Enabling/disabling and deleting cookies

6. USER AGREEMENT
